The undersigned hereby makes, constitutes and appoints each of Scott M. Storer, Marie T. Washburn, Bruce A. Leicher, Alejandra Carvajal, Christopher S. Kiefer and Andrea J. Paul, signing singly and each acting individually, as the undersigned's true and lawful attorney-in-fact with full power and authority as hereinafter described to:

- (1) execute for and on behalf of the undersigned, in the undersigned's capacity as a director and/or an officer of Momenta Pharmaceuticals, Inc.
